



## COVID-19 Safety Protocols

**All patrons, employees, contractors, volunteers and artists must be fully vaccinated against COVID-19 and starting February 1, 2022, must have a booster if eligible.** Please note that the information below is subject to change. Please check for the latest updates before attending a Bach Dancing & Dynamite Society (“Bach”) concert.

### Patron requirements:

**Vaccination Requirements and Proof and Valid ID**-Ticketholders are required to provide a valid government issued photo ID and proof of full vaccination upon entering the Bach for concerts prior to February 1, 2022. Starting February 1, 2022, a booster shot is also required, if eligible. The Bach accepts the following vaccination records:

- Original CDC vaccination card or photo of original card with all fields visible
- California or other digital COVID-19 Vaccine Record that includes name, birthdate, manufacturer, and dosage dates, in addition to the QR code.

Name and birthdate on ID and vaccination record must match. No refunds or credits if proper ID and vaccination record are not provided at the door.

#### For concerts held after February 1, 2022:

Proof of up-to-date vaccination against COVID-19 is required for everyone—including full vaccination and a **booster shot**, if eligible.

#### For concerts held before February 1, 2022:

Proof of full vaccination against COVID-19 is required for everyone. Booster shots are recommended.

Full vaccination - This is defined as completion of the two-dose regimen of Pfizer or Moderna vaccines, one dose of Johnson & Johnson vaccine, or other World Health Organization (WHO)\* authorized COVID-19 vaccines administered two weeks or more in advance of the concert. \*Contact us in advance of purchasing tickets to verify acceptable proof of any WHO

authorized vaccines other than Pfizer, Moderna or Johnson & Johnson at [customerservice@bachddsoc.org](mailto:customerservice@bachddsoc.org)

Booster shot eligibility - Recipients of the Pfizer or Moderna vaccines become eligible for a booster six months after their second dose, and recipients of the Johnson & Johnson vaccine become eligible two months after their single dose.

Minors - Minors under 18 years old may attend **if fully vaccinated including a booster shot, if eligible\*\*** and may show student ID card, birth certificate or passport in lieu of government issued photo ID and for minors under 12 an ID is not required as long as they are accompanied by fully vaccinated parents/guardians. Vaccine proof required is the same as for adults.

\*\*Recipients of the Pfizer vaccine who are 16 or 17 years old become eligible for the booster shot six months after their second dose of that vaccine and must therefore show proof of the booster (if 6 months after the second dose.) If other minors become eligible for the booster shot, proof of the booster will also be required of those minors to attend concerts.

**Masks** - In compliance with current California and San Mateo health directives, masks must be worn inside the venue at all times, except when actively eating or drinking in designated areas. **Note:** Currently drinks are not allowed in the main concert room (and food never has been) and therefore masks must be worn in the concert room with no exceptions.

**Other** - Please follow all posted guidelines and onsite signage, as well as any verbal instructions from staff and volunteers.

## **Door Procedures:**

Prior to entering the venue, please have ID and vaccination record ready to present. After verifying your vaccination status we will check you in for the concert from our door list and provide your wrist band with seat number. Printed or digital tickets are not required. Once the concert room opens, volunteer ushers are available to help you find your seats.

## **Additional Safety Protocols:**

**Ventilation** – Doors and windows will be open for maximum ventilation. The Bach recently installed windows in the front entrance area, operable skylights in the west side of the concert room, air purifiers and fans in the mezzanine.

**Public restrooms** – Equipped with touchless fixtures.

**Disinfecting** – Occupied areas are cleaned and sanitized between events and high touch surfaces will be cleaned between sets.

**Supplies** – Masks, hand sanitizer, and disinfecting wipes are available by request.

## **COVID-19 Pandemic Liability Limitation:**

In purchasing tickets for an in-person concert at the Bach Dancing & Dynamite Society (Bach), you attest that you, and each person you purchased a ticket for, acknowledge the contagious nature of the Coronavirus/COVID-19 and that the CDC and other public health authorities may recommend masks, social distancing, and/or full vaccinations for indoor events.

You further acknowledge that the Bach has implemented preventative measures to reduce the spread of the Coronavirus/COVID-19, however even with these measures, you further acknowledge that the Bach cannot guarantee that you will not become infected with the Coronavirus/COVID-19. You understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of yourself and others, including, but not limited to Bach employees, contractors, volunteers and other participants.

You voluntarily seek to participate in the activities run by the Bach and acknowledge that you are increasing your risk to exposure. You acknowledge that you must comply with all set procedures to reduce the spread while participating.

For the holder of each ticket you purchased, you attest that: You and all ticket holders have been fully vaccinated and have received a booster shot if eligible (and submit proof of same.)

You hereby release and agree to hold the Bach harmless from and waive on behalf of yourself, your heirs, and any personal representatives any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to yourself, your child, and/or property that may be caused by any act, or failure to act of the organization, or that may otherwise arise in any way in connection with any services received from the Bach. You understand that this release discharges the Bach from any liability or claim that you, your heirs, or any personal representatives may have against the organization with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any activities provided by the Bach. This liability waiver and release extends to the organization together with all directors, employees, contractors and volunteers.

This acknowledgement and waiver applies equally to the holders of all tickets purchased by you. It is your responsibility to ensure that each individual reads and agrees to the terms of this waiver prior to requesting and purchasing tickets for a Bach in-person event.
